In the spirit of affording employees the opportunity to spend quality time with family and friends during the spring holiday season, and in appreciation of our employees,






**ORDER CLOSING SAN ANTONIO UNITED STATES COURTHOUSE
ON FRIDAY, APRIL 26, 2024 FOR BATTLE OF FLOWERS PARADE**

Before the Court is the issue of 500,000 people in downtown San Antonio for the Battle of Flowers Parade on April 26, 2024, and the related street closure and traffic problems caused thereby. Moreover, San Antonio schools, businesses and Bexar County government offices close for the Battle of Flowers Parade.






